- 4. 報名費:港幣40元正,無論申請成功與否,報名費概不退還

申請「2025/26幼稚園入學註冊證」

- 1. 在幼稚園教育計劃(下稱「計劃」)下,每名可在本港接受教育的兒童只會獲發 一張註冊文件,而所有參加計劃的幼稚園,只可取錄持有有效註冊文件的兒 童。
- 2. 家長須於 2024年9月至11月期間為其子女向教育局申請「幼稚園入學註冊證」 (下稱「註冊證」)。「註冊證」會於本年9月開始接受申請,屆時教育局會公布 申請細則,並會在教育局網頁(https://www.edb.gov.hk/k1-admission tc) 上載詳情。如申請人在遞交申請時已提供全部所需資料及文件,教育局一般可 在六至八個星期內完成審核,並以郵遞方式發放「註冊證」給合資格接受計劃 資助的申請人。如兒童可於本港接受教育但不合乎資格接受計劃資助而未能獲 發「註冊證」,本局會為有關兒童發出「幼稚園入學許可書」,兒童可憑「入學 許可書」註冊並入讀參加計劃的幼稚園,惟其家長須按註冊入讀之幼稚園的收 費證明書繳付未扣減計劃資助前的全額學費。

收生準則:

- 1. 在讀學生之弟妹、畢業生子女/弟妹;
- 2. 父母為本校教職員;
- 3. 父母為嗇色園工作之職員;
- 4. 家長認同嗇色園辦學宗旨、理念及學校發展方向;
- 5. 居於同區;
- 6. 面試時學生及家長表現
- 7. 如申請全日班學位,有家庭需要的申請人可獲優先考慮 (請留意由於學位所限,並非所有符合優先考慮的申請人均會獲取錄。)

面見安排:

- 1. 本校會安排面見所有申請入讀幼兒班的兒童
- 2. 面見日設於2024年11月2日(星期六)進行,本校會另函通知家長
- 3. 以個别形式面見
- 4. 家長須陪同兒童參與面見
- 5. 在面見非華語兒童時,學校可按需要為申請人安排傳譯及/或翻譯服務,或家長和兒童由懂中文的親友陪同會面,協助溝通。如需要傳譯及/或翻譯服務請致電 2324 8201或電郵至本校info@holapkg.edu.hk與本校蔡書記聯絡。

取錄結果公布:

本幼稚園將於2024年12月13日或之前以郵遞方式通知家長幼兒班取錄結果。

註册安排:

- 1. 取錄生:家長須於2025年1月2日至4日(「統一註册日期」)內的指定時間到本校 辦理註册手續,並須提交「2025/26註冊證」正本及繳交註冊費。
- 2. 備取生:本校會以書面方式發出通知,請家長於指定日期到本幼稚園辦理註冊 手續,並須提交「2025/26註冊證」正本及繳交註冊費。
- 3. 家長請留意,如未能在指定的註冊日期提交有效的註冊文件,本校或未能為獲取錄兒童完成手續,因此家長務必於指定日期內向教育局申請相關註冊證。
- 4. 2025/26學年的半日班註冊費為港幣970元正、全日班註冊費為港幣1570元正。 如有關兒童入讀本校,本校會於9月退回註冊費,但若家長於註冊後決定為子女 轉校,請以書面通知本校。本校會退回相關註冊證,但註冊費將不獲退還。在 取回註冊證後,本校亦不會再為該兒童保留學位。

Information on Admission to K1 Classes in the 2025-2026 School Year

Collection of application Forms (No quota):

- 1. Obtain from school in person
- 2. Request by post
- 3. Download from Sik Sik Yuen website

Distribution Period:

- 1. Date: 2 May 2024 (Thursday) to 31 Oct 2024 (Thursday)
- 2. Time: 9 a.m. to 5 p.m. (Mondays to Fridays) / 9 a.m. to 1 p.m. (Saturdays)

Return of Application Forms (No set quota for the kindergarten):

- 1. Date: 2 May 2024 (Thursday) to 31 Oct 2024 (Thursday)
- 2. Time: 9 a.m. to 5 p.m. (Mondays to Fridays) / 9 a.m. to 1 p.m. (Saturdays)
- 3. Return method: Submit the application form in person / by post [together with the documents required (including soft copy of identity document / immunization record, one child's photo and 4 self-addressed stamped envelopes.)]
- 4. Application fee: HK\$40

 The application fee is non-returnable whether the application is successful or not.

Application for the "2025/26 Registration Certificate for Kindergarten Admission"

- 1. Under the kindergarten (KG) education scheme (hereafter referred to as "Scheme"), each child who can receive education in Hong Kong will only be issued a registration document and all Scheme-KGs can only admit children holding a valid registration document.
- 2. Parents are required to submit an application for the Registration Certificate for Kindergarten Admission (hereafter referred to as "RC") to the EDB from September to November 2024. The RC will be open for applications in September 2024 and the EDB will announce and upload the details of application onto the EDB's website(https://www.edb.gov.hk/k1-admission_e) in due course. Upon receipt of the applications with all necessary information and documents provided, the EDB will generally take six to eight weeks to complete processing of the applications and issue the RC to applicants who are eligible for receiving subsidy under the Scheme by post. If a child cannot obtain an RC as he/she can receive education in Hong Kong but is not eligible for receiving subsidy under the Scheme 2, the EDB will then issue a Kindergarten Admission Pass (hereafter referred to as "AP") to the child concerned for registration and admission to a Scheme-KG but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the KG to which the child is admitted.

Admission Criteria

- 1. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration.
- 2. Parents are working in our kindergarten.

- 3. Parents are the staff of Sik Sik Yuen.
- 4. Parents will need to acknowledge our kindergarten mission and follow our vision.
- 5. Living near in our kindergarten.
- 6. Interview performance.
- 7. The applicant from families in need will be given due priority consideration when applying for whole day.

(As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.)

Interview Arrangements

- 1. Our kindergarten will arrange interview for all applicants
- 2. Interviews will be conducted on 2 November 2024 (Saturday). We would notify parents by mail.
- 3. Individual interviews will be arranged.
- 4. Parents should accompany their child for the interview
- When interviewing NCS children, interpretation and/or translation service for applicants will be provided where necessary; or parents and children are allowed to be accompanied by a Chinese speaking relative/friend to facilitate communication. Announcement of Admission Results

We will inform parents of the K1 admission results before 13 December 2024 by post.

Registration Arrangements

- Successful applicants: Parents should complete the registration procedures for their child from 2 to 4 January 2025 ("Centralised Registration Dates") by submitting the original of the "2025/26 RC" to our kindergarten and paying the registration fee.
- 2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by post. Parents are required to submit the original of the "2025/26 RC" to our kindergarten and pay the registration fee.
- 3. Please be reminded that if parents cannot submit the "2025/26 RC" during registration, our kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period.
- The registration fee for 2025/26 K1 place is HK\$970 (half day classes) / HK\$1,570(whole day classes). Should parents decide to change school after registration, please notify the kindergarten in writing. Our kindergarten will return the "2025/26 RC" but the registration fee will not be refunded. Upon obtaining the "2025/26 RC", our kindergarten will no longer keep the school place for the child.
